### About the Position

Located in the Office of Research Services, Research Portfolio, the position of Manager, Research Information and Systems Support (RISS) will be responsible for the management and coordination of high quality services in relation to the University's research data, research platforms, and research reporting capabilities.

The incumbent will be required to manage a highly productive team, deliver robust business solutions, and support statutory reporting obligations such as the Federal Government's Excellence in Research for Australia (ERA) Initiative.

This position reports to the Executive Director, Office of Research Services for supervision, workload management and for Performance Planning and Review (PPR).

#### Key responsibilities include:

- Manage and coordinate the delivery of high quality services in relation to the University's research data, research platforms including RAD, and research reporting capabilities.
- Support the University's Research Centre Initiative by adhering to the endorsed nonmembership model and complying with the research attribution framework.
- Support the University's response to the Federal Government's Excellence in Research for Australia (ERA) Initiative and the Engagement and Impact Assessment cycles.

- Ensure the University's research data and research platforms are trusted, accurate, reliable, and accessible by the QUT community.
- Deliver clear and concise research reports that enable managers to monitor research quality and research performance and inform senior executives to make well considered strategic decisions.
- Develop, in conjunction with the Executive Director, operational and strategic goals for the RISS team that foster a cohesive team culture, deliver client focused services, and promote best practice principles of data management.
- Provide leadership and direction in guiding the RISS team through organisational restructures, business transformations, and digital growth.
- Actively engage with stakeholders, partners, and the QUT community to facilitate client focused initiatives, develop value-add business solutions, and deliver high quality research services.
- Provide recommendations and provision for future state solutions to ensure business continuity in relation to the deployment and optimisation of research management systems and the design and implementation of research reporting capabilities.
- Compliance with health and safety policies, procedures, hazard reporting and safe work practices.

To ensure job flexibility the successful appointee may be required to:

- perform any other duties as nominated by the University consistent with the relevant classification descriptors detailed in the Enterprise Agreement. Staff undertaking any new duties will receive training;
- participate in job rotation or multiskillingin consultation with their supervisor;
- work across campuses.

# Selection Criteria

- Education, training, and/or relevant experience equivalent to the completion of postgraduate qualifications and extensive experience in data management.
- Demonstrated knowledge of processes, applications and comparative analytical methodologies used in performance monitoring and quality metrics, together with experience of corporate systems, complex relational databases, and research management platforms.
- Demonstrated high level digital literacy and competency in the use of information technology, in particular data management concepts, development of reports and dashboards, and the ability to design robust business solutions.
- Demonstrated analytical skills relating to interpretation of data, information, policies and procedures with reference to corporate research data management, research quality, and research performance.
- Demonstrated highly developed interpersonal and verbal communication skills including the ability to lead a productive multi-skilled team and engage with senior executives to achieve successful outcomes.
- Demonstrated highly developed written communication skills including the ability to deliver clear and concise reports and articulate proposals to achieve operational and strategic goals.
- Demonstrated ability to be agile to meet overlapping deadlines and effectively manage competing priorities with a commitment to delivering high quality services.

#### **Remuneration and Benefits**

The classification for this position is Higher Education Worker Level 9 (HEW9) which has an annual remuneration range of \$133,814 to \$140,187 pa. Which is inclusive of an annual salary range of \$114,040 to \$119,470 pa and 17% superannuation.

In July 2020 QUT staff voted in favour of a variation to its Enterprise Agreements. The variations were approved by the Fair Work Commission in August 2020.

The variation impacts leave loading (for new staff no loading will be paid or accrued during the period the variation is in effect), salary increases (the salary increase which was due to occur in the first full pay period of December 2020 has been deferred until the first full pay period of December 2021) and superannuation (superannuation will be paid to staff as though the salary increase which would have been paid in December 2020 has taken effect and, subject to the rules of the superannuation fund, a defined benefit member will continue to make contributions in alignment with the contributions made by the University).
