About the Chancellery Division

The Vice-Chancellor and President is responsible to Council for providing leadership to the University and for the academic, financial and administrative functions of the University. The Vice-Chancellor is also QUT's chief representative on external forums.

The Vice-Chancellor leads the Chancellery Division which includes the Business Development and International Portfolios, Indigenous Strategy, Government Relations and Policy, Assurance, Risk and Integrity Services, Marketing and Communication, and Finance Business Solutions.

The Office of the Vice-Chancellor provides support and manages the business of the Vice-Chancellor and Chancellery Division. The Chancellery supports the University Executive in fulfilling their responsibilities to Council for providing leadership to the University and its academic, financial and administrative functions.

About Marketing and Communication

The Marketing and Communication Department is responsible for:

- Building and protecting QUT's brand and reputation
- Engaging and recruiting future students
- Ensuring communications from QUT are effective and of high professional standard.

As well as professional services provided to the university community, the Department is responsible for a variety of corporate communication functions and oversees relevant policies, protocols and governance arrangements.

About the Position

The Marketing Consultant is a key liaison between the faculty and the Marketing and Communication Department, developing marketing campaigns and coordinating the full range of communication activities aimed at supporting the faculty in achieving its student recruitment goals.

The Marketing Consultant oversees the implementation and evaluation of the reputation and recruitment campaigns and plans for the faculty.

This position reports to the Faculty Marketing Partner for supervision, workload management and for Performance Planning and Review (PPR).

Key responsibilities include:

- Provide strategic advice, develop and implement marketing and advertising campaigns and strategies for the purpose of furthering the reputation and future student engagement and domestic supporting the student recruitment goals of the faculty.
- Manage and monitor the faculty marketing and advertising campaign budgets.
- Develop and maintain excellent working relationships with internal and external stakeholders to deliver effective campaigns.
- Coordinate the participation of the faculty in recruitment events and QUT-wide promotional activities (e.g. QUT Open Day, TSXPO).
- Define and manage the course and marketing content needed for the recruitment campaigns in liaison with the Marketing Content Officer, the web team, student recruitment and the digital marketing team.
- Be accountable for ensuring communications comply with the Competition and Consumers Act, SPAM Act and ESOS Act.
- Compliance with health and safety policies, procedures, hazard reporting and safe work practices.

To ensure job flexibility the successful appointee may be required to:

 perform any other duties as nominated by the University consistent with the relevant classification descriptors detailed in the Enterprise Agreement. Staff undertaking any new duties will receive training;

- participate in job rotation or multiskilling in consultation with their supervisor;
- work across campuses.

Selection Criteria

- Education, training and/or experience equivalent to postgraduate qualifications or progress towards postgraduate qualifications with extensive relevant experience in marketing or a related discipline.
- 2. Demonstrated ability to develop and maintain excellent relationships with key stakeholders.
- 3. Demonstrated experience in developing, implementing and evaluating strategic marketing plans and campaigns.
- 4. Demonstrated experience in supervising marketing and communication activities and tailoring such activities to different target audiences.
- 5. High level interpersonal skills with demonstrated experience in negotiation, presentation and liaising with internal and external stakeholders.
- 6. Strong written communication skills with the ability to develop targeted product messages for translation across web, advertising, print and digital channels.
- Demonstrated event management skills with the ability to coordinate strong faculty representation at central recruitment events and provide advice to clients for faculty-specific events.

Remuneration and Benefits

The classification for this position is Higher Education Worker Level 8 (HEW8) which has an annual remuneration range of \$114,686 to \$129,990 pa. Which is inclusive of an annual salary range of \$97,738 to \$110,781 pa and 17% superannuation.

In July 2020 QUT staff voted in favour of a variation to its Enterprise Agreements. The variations were approved by the Fair Work Commission in August 2020. The variation impacts leave loading (for new staff no loading will be paid or accrued during the period the variation is in effect), salary increases (the salary increase which was due to occur in the

first full pay period of December 2020 has been deferred until the first full pay period of December 2021) and superannuation (superannuation will be paid to staff as though the salary increase which would have been paid in December 2020 has taken effect and, subject to the rules of the superannuation fund, a defined benefit member will continue to make contributions in alignment with the contributions made by the University).
